## **OLD BUSINESS:**

1. **Update of dock replacement:** As noted above, there is no power to the docks. (**OPEN – Eric**)
2. **Maintenance of EYC grounds:** Since we cannot get FSS to mow what or when we want, it was decided to find another avenue for our grass cutting needs. (**OPEN – Eric**)
3. **HVAC Replacement:** On December 11, Eric received the following information from Mr. Alexander about our request for the HVAC improvements: "I received notification that this type of system is not currently supported by the Civil Engineer Group (CEG). As Air Force (AF) real property is involved, I requested a formal opinion from CEG to ensure compliance with all applicable Air Force regulations and requirements. Prior CEG approval is mandatory before proceeding with any modifications to real property. Furthermore, I relayed that all necessary work would be contracted by the FSS at EYC expense. This means that Force Support Squadron (FSS), Community Services would procure the necessary contract for the installation, with the EYC covering the contractor's fees and any associated FSS manpower costs. At this time, CEG has not provided that follow up."

We are awaiting word on approval. (**OPEN – Eric**)

**NEW BUSINESS:**

1. **Replacement Volunteer:** After discussion, it was decided to invite Mark Koch, who volunteered, to be a member on the Advisory Council. Eric will contact Mr. Koch. If he accepts our invitation, he will begin his term in January.
2. **Special Guest:** Chaplain, Amber Guerin. Chaplain Guerin presented several proposals to have events at the EYC. After discussing several alternatives, the issue was tabled until the next meeting.
