**Financial Report:** Cindy Smith-Wojdac reported that we had an adjusted net income of \$438.69 for July as compared to \$67.35 this time last year. The rolling 12-month NIAD for last month was \$4,347.35 as compared to \$5,548.13 last year.

**Special Functions:** Fred Westfall reported that there were no special functions in July and none scheduled for August. We have two December reservations by AFLC/EBO and EBJ for their Christmas parties, both of which need a sponsor.

**Entertainment:** Susan Jacobs reported that the July Family Night was cancelled due to other activities for the holiday. The August Family Night was hosted Paul Goodenough and he will be having a Mexican themed event for the August Membership Night. The Dive Flight crew will host the September Membership Night.
